Welcome to **Postbrew**! These Terms of Use ("Terms") govern your use of Postbrew and outline your rights and responsibilities. By using the App, you agree to these Terms. If you do not agree, you may not use the App.

Postbrew is an independent project provided by the developer ("we," "us," or "our").

1. The Postbrew Service

Postbrew is a coffee brewing tracker app. Its primary functions include:

- **Recording and analyzing coffee brews:** You can log details such as coffee type, roast, grind, water ratio, brew time, and tasting notes.
- **Viewing and managing your brew history:** Data you record is stored securely in **Supabase** and linked to your account via **Google Sign-In or Microsoft Sign-In through WorkOS**.
- **Providing usage insights and diagnostics:** Aggregate or anonymized data may be used to improve app stability, performance, and features.

Currently, Postbrew does **not** include social features, public profiles, or content sharing.

2. Who Can Use Postbrew

By using the App, you represent that:

- You are at least 13 years old.
- You are not prohibited from receiving any aspect of the App under applicable laws.

3. Account and Authentication

- Postbrew uses **Google Sign-In and Microsoft Sign-In through WorkOS**. You are responsible for keeping your authentication credentials secure.

- Your email and basic Google or Microsoft account information are used only for authentication and to link your brew records.
- All other data (brew records, notes, usage data) are stored in Supabase.

4. Your Responsibilities

While using Postbrew, you agree:

- To enter accurate information about your brews.
- Not to attempt unauthorized access to the App, its systems, or other users' data.
- Not to interfere with the App's functionality, including attempts to manipulate data or bypass authentication.

5. Data Usage and Permissions

- You retain ownership of all brew data you submit.
- By using the App, you grant Postbrew permission to store, process, and display your data in connection with your account.
- Postbrew does **not** claim ownership of your data and does not use your data for advertising, marketing, or sale.

6. Content Removal and Account Deletion

- You can delete your account at any time. Upon deletion, all brew data associated with your account will be permanently removed from Supabase.
- We reserve the right to suspend or disable accounts for abuse, unauthorized access, or violation of these Terms.

7. Liability and Warranties

- Postbrew is provided “**as is**” and without warranties of any kind.
- We are not responsible for any inaccuracies in the data you record, app downtime, or data loss.
- Our liability is limited to the fullest extent permitted by law.

8. Disputes and Arbitration

By using the App, you agree to resolve disputes individually through binding arbitration, waiving any right to participate in class-action lawsuits.

9. Children's Use

Postbrew is not intended for children under 13. We do not knowingly collect data from children under 13. If you believe a child has provided personal data, contact us to request deletion.

10. Changes to These Terms

We may update these Terms from time to time. Updates will be reflected by the "Effective Date" at the top. Continued use of the App after changes constitutes acceptance of the new Terms.
